

2. ABOUT RANKING SYSTEM

GENERAL INFORMATION ABOUT THE RANKING SYSTEM




- The WPC has developed a unique ranking system that identifies the best teams of each member of the community, to build a transparent and harmonized system for determining GotF and GotF qualifier participants
- The ranking system is harmonious and includes not only sports metrics, but also marketing metrics, and the final score of a team is influenced by the level of the tournament in which it participates (WPC member ranking). This mechanism is designed to popularize and develop phygital sport in those countries where tournaments are held
- For the season 24/25 WPC has laid down the possibility for members of the community to organize a full qualifying cycle with Regional Qualifications and National Tournaments, or to organize it in a «truncated» format with National Tournaments only
- The ranking system unifies the requirements for the format and number of Regional Qualifications and National Tournaments
- The key to successful tournaments is to immerse yourself in the WPC regulations!

Min. 2 tournaments

Regional Qualifiers

- ✓ Conducting tournaments in the PI format is mandatory
 ✓ The calculation of ranking points for all tournaments
- starts with 1/4
- √ The winning teams must save at least 70% of their player's squad to participate in the NT

Min. 6 tournaments with at least 8 teams each

The main tournament with 8 or 16 teams


National tournaments

- ✓ Conducting tournaments in the PI format is mandatory.
- √ The winning team must save at least 70% of their player's squad to participate in the GQ

The main tournament with 16 or 32 teams

3. THE PROCEDURE FOR DETERMINING GOTF'25 PARTICIPANTS



REGIONAL QUALIFIERS WINNERS GET THE OPPORTUNITY TO TAKE PART IN THE NATIONAL TOURNAMENTS



SUBMISSION OF APPLICATIONS FOR TOURNAMENTS



STEP 1

INITIAL SUBMITION

After you become a member of the WPC, you will be provided with links in your personal account to fill out application forms for regional qualifications and national tournaments in disciplines for which you have received confirmation from the WPC.

Deadlines

Regional qualifications – until 09/01/2024 National tournaments – until 11/01/2024

SUBMISSION OF APPLICATIONS FOR TOURNAMENTS



STEP 2

APPLICATION REVIEW

All information from the filled-out forms is received by the WPC (sports, marketing, broadcast and international departments)

Any of these departments can contact you with a request to finalize the application. If there are no comments on the application, then the next step is 4, if there are any, then the next step is 3

Deadlines

The application review period is 3 business days from the date of completion.

STEP 3

REQUEST FOR MODIFICATIONS:

If it is necessary to amend the application, the WPC member will receive an email containing information about the necessary amendments, and the member will need to re-fill out the form in accordance with the comments.

Deadlines

The deadline for making amendments is 3 working days from the date of receipt of comments.

STEP 4

FILLING OUT TECHNICAL RULES TEMPLATE

If the WPC has no questions about the application, then the WPC Sports Department sends a letter to the WPC member to the email specified in the application with a template of technical rules to fill in.

In the technical rules, the WPC member fills in the basic sports information about the tournament:

- the number of teams;
- the format of the tournament;
- the equipment and inventory used, etc.

The WPC member sends the completed template by reply letter.

Deadlines

The deadline for filling out templates is 3 business days from the moment they are received by mail.

STEP 5

TECHNICAL RULE'S REVIEW

The WPC Sports Department reviews the completed Technical Rules template. By a reply letter, the WPC Sports Department agrees or does not agree with them, stating the reasons, what needs to be added or redone, and then WPC Member send them again for approval.

Deadlines

The deadline to review templates is 3 business days from the time you receive them in the mail.

STEP 6

FILLING OUT OTHER DOCUMENTATION

- After the agreement of the Technical Rules, the WPC Member receives a link to a folder on One Drive with the regulatory documentation required for the tournament:
 - Rulebook (for study)
 - Ranking regulations (for studying)
 - Key requirements: general, marketing (for studying)
 - Team application templates (to be filled in by teams)
 - Referee and disciplinary docs (to be studied and filled in)

The WPC member should proceed to complete and sign the necessary documents for the event.

Deadlines

The deadline for completing the document templates is no later than 3 weeks before the start of the competition.

STEP 7

FILLING OUT DOCUMENTS FOR THE TOURNAMENT ORGANIZATION

WPC member during a tournament must:

- Conduct the draw of the teams
- Generate match protocols based on the protocol template
- Fill in the template for calculating the ranking of teams, which also automatically generates tournament grids during the tournament
- Automatically calculate the ranking of each team during the tournament and upon its completion, in accordance with the ranking regulations, using the template
- Form the final protocol at the end of the tournament
- Generate a final summary of the teams' ranking

Deadlines

All documents are generated when matches are completed.

COLLECTION OF REPORTING DOCUMENTATION



STEP 8

REPORTING

At the end of the tournament, the WPC Member will post the signed tournament report documentation and other materials in his OneDrive folder:

- Tournament technical rules
- Applications (teams, referees) & Match reports and protocols
- Ranking calculation at the end of the tournament
- Ethical and anti-doping declarations of the participants
- Regulations (main panel of judges, Disciplinary Committee, prize pool etc.)
- Photo reports (venues, field of play, equipment, spectators) & Video reports
- Links

Deadlines

Deadline for submission of reporting documentation - no later than 3 business days after the end of the tournament.


